I write to remind you that subscriptions, including payments for periodicals for personal use, for the session November 2023–October 2024 **become due on 1 November 2023**, and should be paid **no later than 1 December 2023** (except for Direct Debits, see below).

Access to your membership record online

Members can now access their own records online by logging on to the Society's website: www.lms.ac.uk/user and clicking on the "My LMS Membership" tab. The tab contains the relevant information about a member as held by the Society, including contact details and information about their membership and, where applicable, journal subscriptions. Paying your subscription:

- Direct Debit Payments: The Society encourages members to pay by direct debit. - o If you take a free electronic subscription to *Nonlinearity*, your email address will be passed to the Institute of Physics who will contact you with details on how to access the journals.

NOTES

SUBSCRIPTIONS

- 1. The basic subscription includes free online access to journals.
- 2. The subscription is not payable by a member who:
- (i) is an Honorary Member; or
- (ii) has paid annual subscriptions for not less than 35 years.

If you claim free basic subscription, please indicate the reason clearly on the subscription form.

- 3. <u>Tiered Ordinary membership fees</u> are now available. Members who pay the Ordinary membership rate should confirm which membership rate they wish to pay based on whether their annual professional income falls within the following ranges: Above £70,000 per annum: Ordinary (high) rate. Between £40,000-£70,000 per annum: Ordinary (middle) rate. Up to £40,000 per annum: Ordinary (low) rate.
- **4.** <u>Selected discounted rates</u> on Ordinary membership are available to members, as follows:
 - i.Reciprocity membership is available to members who are not normally resident in the UK **and** who are also a full member of one the Society's Reciprocity partners, as listed on the Society's website.
 - **ii.** Associate Post-doc membership is available to early career members whose Associate membership recently expired now that three years has passed since their PhD, who would normally be upgraded to Ordinary membership and who are currently on a fixed-term contract.
 - iii. Retired membership is available to all current members who have retired from their professional careers.
 - **iv.**Concessionary membership is available to members who have returned to full-time education, are on a career break or in part-time working, or are unemployed or otherwise in hardship.
- **5.** Lifetime membership fee is one-off payment that consists of the number of unpaid years towards 35 years of continuous membership multiplied by the Ordinary (middle) membership rate in the membership year in which the lifetime fee is paid.

- **6.** Figures quoted in USD are set at this rate for payments by personal cheques and bank transfers to allow for bank and postal charges. If paying by card, payment will be in GBP at the exchange rate on the payment date.

- **7.** The membership benefits also allow individual members to sign up for access to the *Bulletin*, *Journal*, *Proceedings of the LMS*, *Mathematika* and *Nonlinearity* online, free of charge.
- > Subscriptions to Bulletin, Journal and Proceedings of the LMS and Mathematika are administered by Wiley.
- > Subscriptions to Nonlinearity are administered by the Institute of Physics.

 In common with other mathematical societies, the Society views a subscription as for personal use only if electronic subscriptions are only for personal use and are not to be shared with other mathematicians.
- **8.** The Society reserves the right to discontinue the supply of free online access to these journals to members whose subscriptions remain unpaid by 1 December 2023 (where the subscription arrives after 1 December, free online access will be supplied but with some delay).
