## GENERAL MEETING

There will be a general meeting of the Society on Friday, 17 October 1980 at 3.30 p.m. in the Meeting Room of the Geological Society, Burlington House, Piccadilly, London W1V 0NL, to consider a proposal by the Council of the Society to delete the existing By-Laws II, 1 and II, 3 and to substitute those printed below.
The purpose of this change is to revise the annual subscription of individual Members and of Corporation and Institutional Members.

## Text of Proposed By-Law II, 1

The annual subscription of the Society shall be $£ 5$. The prices of the Society’s periodicals to individual Members shall be $£ 5$ per volume.

## Text of Proposed By-Law II, 3

The annual subscription to the Society of Corporation and Institutional Members shall be $£ 155$, inclusive of one volume of the Bulletin and two volumes of the Journal and Proceedings; except that those Corporation and Institutional Members who have more than one Representative shall pay an additional annual subscription of $£ 5$ for each Representative in excess of one.

## L.M.S. STAFF EXCHANGE SCHEME

The Society has agreed with most Universities in Britain that members who wish to exchange their positions for short periods (up to one year) may do so. The idea is to help overcome the feeling of stagnation in a time of no expansion and little natural movement of staff. The plan, in outline, is that a member on an exchange would continue to be paid by his home University, but would work in the department he was visiting; the main disadvantage is that the cost would have to be borne by
the exchangees (only one or two Universities have any funds to support this kind of venture). ## L.M.S. COUNCIL NEWS

At the Council meeting in June the death was reported of Professor R. Nevanlinna, an Honorary Member of the Society since 1959. Professor S. J. Taylor was appointed Proceedings Secretary, to succeed Dr. Collins; Mr. N. L. Biggs of Royal Holloway College was appointed Newsletter Editor, to succeed Professor B. E. Johnson, and Professor P. M. Cohn of Bedford College was appointed Joint Editor of the Monographs Series, to succeed Professor H. Halberstam. A reply was sent to Professor

Swinnerton-Dyer's Committee on the Academic Organisation of London University; and discussions were set in hand for a Reciprocity Agreement with the Société Mathématique de France. The 1980 Senior Berwick Prize was awarded to Professor C. Hooley, and 1980 Junior Berwick Prizes to Dr. J. T. Stafford and Dr. H. G. Dales. It was also agreed to nominate Professor Hassler Whitney as an Honorary Member at the October meeting of the Society.

## ADMINISTRATIVE ASSISTANT

The Society intends to appoint a full-time Administrative Assistant to take care of the Society office at Burlington House, London W1. The salary will be within the universities' clerical Grade 4 or Grade 5 (depending on experience and qualifications) with London allowance. Hours are flexible.

The work involves general correspondence with members and publishers, oversight of members' subscriptions and periodicals orders, receipt and payment of cheques, some book-keeping in connection with the Society's accounts, receipts of books and journals sent for review, and general assistance to the Officers of the Society most of whom are based outside London. The office forms part of the Royal

Astronomical Society premises and relations with the R.A.S. and B.A.A. staff are excellent.

An existing interest in the mathematical community would be an advantage and the post might particularly suit someone with a past or present connection with a mathematics department whether as a secretary or as a student or through informal contact. The help of members of the Society is sought in mentioning the post to likely applicants.

## SUBSCRIPTIONS

At its meeting in June the Council decided to continue its programme of support for conferences and overseas visitors, to increase the size of the Bulletin, and to seek a full-time Administrative Assistant for the office in Burlington House which is at present manned only two days per week. It also decided to increase the basic subscription to $£ 5$ in 1980/81 ( $£ 2 \cdot 50$ for reciprocity members).

The price of the Bulletin, Journal and Proceedings will be held at $£ 5$ per volume in 1981 for individual members of the Society. This means that for a total outlay of $£ 30$ an individual member can obtain five volumes with a commercial price of $£ 186$. The price
of corporate membership, which includes the same five volumes, was fixed at $£ 155$ for 1981.

Subscription forms will accompany the November Newsletter. The recent, and probably continuing, changes in all prices combined with the substantial amount of correspondence generated by incomplete subscriptions mean that it is no longer practicable to deal with standing order payments. I would be grateful if any member who still has an outstanding standing order to the Society would ask their bank to cancel it before November.

## L.M.S. PROGRAMME COMMITTEE

Council has again set aside a fund to enable the committee to support conferences. The only such support requested during 1980 was $£ 1000$, awarded to H. Halberstam and R. Odoni for the "Journées Arithmetiques" (Exeter, 13-19 April).

Three grants for 1981 have already been made: $£ 600$ to J. F. Adams, I. M. James and E. Rees for a topology symposium in Edinburgh ( 30 June-2 July), $£ 600$ to P. T. Johnstone for a conference on category theory in Cambridge (19-25 July), and $£ 400$ to C. M. Campbell and E. F. Robertson for a conference on group theory in St. Andrews (26 July-1 August).

The fund may also be used to support overseas visitors, in the scheme advertised a year ago. Members are reminded that in
cases accepted for support the Society pays the overseas fare and the proposing institutions are expected to cover subsistence. A condition of all grants is that lectures are advertised in the Newsletter and open to all Society members.

Last year three overseas visitors were supported: G. Betsch (Tübingen) visited Teesside Polytechnic and Edinburgh from 25 February to 9 March; J. Aaronson (IHES) visited Imperial College and Warwick in mid-March; A. Hulanicki (Wroclaw) visited Manchester, Aberdeen, Newcastle and Cambridge during the period 8-15 May.
Enquiries about either scheme and applications for support should be addressed to the President. It is desirable to apply at an early stage.

## SALEM PRIZE

The Salem Prize for 1980 was awarded to Stylianos Pichorides of the Nuclear Research Center "Democritus" (Athens), for his work on Littlewood's conjecture concerning the $L^{1}$ norm of idempotent trigonometric polynomials. The prize established in 1968, is given every year to a young mathematician who is judged to have done an outstanding work in the field of interest of Salem, primarily on Fourier series and related topics. ## BACKLOG OF BRITISH JOURNALS

This information is published with the co-operation of the respective editorial boards. For the sake of uniformity, the same headings have been adopted as in the statements published biennially by the AMS Notices. The following explanatory statements are also so copied:
Backlog. This is an estimate of the number of printed pages which have been accepted but are not necessary to maintain copy editing and printing schedules.

Waiting times. The quartiles $\mathrm{Q}_{1}$ and $\mathrm{Q}_{3}$ are presented to give a measure of dis-
persion. They do not include misleading extremes, the result of unusual circumstances arising in part from the refereeing system.

Waiting times are measured in months from receipt of manuscript in final form to receipt of final publication at the library of Liverpool University. When a paper is revised, the waiting time between an editor's receipt of the final revision and its publication may be much shorter than is the case otherwise, so these figures are low to that extent.

## COMPARATIVE PRICES OF MATHEMATICAL JOURNALS

Members of the Society may be interested in the results of a survey of prices of mathematical journals recently undertaken on behalf of the European Mathematical Council. Editors of over 100 different journals were asked to co-operate by completing a short questionnaire and the majority did so. Although the survey was primarily concerned with journals published in Europe a proportion of nonEuropean journals have been included for purposes of comparison (also it is not always clear in what country an international journal is actually published).
The numerical index opposite the title of each journal may be thought of as "cents per thousand words". To be precise the index is obtained by dividing the cost in U.S. cents of the 1979 volume(s) to an institutional subscriber by the product of the total number of pages in the volume(s) and the word capacity of each page. This last is an estimate of the average number of
thousands of words of plain English text which could appear on a page. For example, a journal costing $\$ 100$ for a 1000 page volume with $500 / 1000$ word capacity pages would have index of 20 .

As will be seen, the indexes range widely, with an average of about 30 . (It should be pointed out that this index is different from the one used in a trial run last year, which was based on the observed word capacity of an average page, making some allowance for formulae. This proved to be too much effort to calculate on the scale required.)

Obviously there are many considerations which affect journal prices, such as extent of circulation, quality of printing, and so forth. The index is simply a very crude measure of relative cost. Nevertheless it is hoped that the results of this survey (which may be repeated from time to time) may be found of some use by editors, librarians and publishers.
